### **CONTEXT**

Military confidence-building measures are an important but underutilized tool in the conflict prevention and resolution toolbox. In the short term, CBMs aim to adjust potentially inaccurate perceptions of military-strategic motives between two or more States, to avoid misunderstandings about military actions and policies, and to foster security cooperation and inter-dependency. Over time, these measures contribute to conflict prevention by stabilizing bilateral and regional relations, transforming ideas about national requirements for security, and encouraging steps to jointly identify shared security needs. By enhancing confidence and trust and by improving military stability, military CBMs can facilitate arms limitations and disarmament and promote conditions conducive for achieving the Sustainable Development Goals.

Through its biennial resolution "Information on confidence-building measures in the field of conventional arms" (A/75/54 of 14 December 2020), the General Assembly requested the Secretary-General to engage with interested Member States and regional organizations on developing and advancing military CBMs, strengthening understanding of this topic and providing substantial and procedural advice and assistance. Additionally, the United Nations Disarmament Commission in its 2017 Report recommended States to consider a set of practical CBMs in the field of conventional weapons, including the establishment of direct channels of communication, reciprocal appointment of points of contacts, periodic exchange of information and the notification of troop movements and military maneuvers and military constraint measures.

Over the past decade, UNODA has widened and deepened its expertise on military CBMs. It has established a Repository of military CBMs – mandated by the General Assembly – containing the most tested and trusted measures. UNODA also maintains several transparency instruments pursuant to General Assembly mandates, notably the UN Report of Military Expenditures and the UN Register of Conventional Arms, which can help reduce mistrust and thereby facilitate arms limitations and disarmament.

Furthermore, through Action 23 (CBMs) of the Secretary-General's Agenda for Disarmament, *Securing Our Common Future*, ODA seeks to advance regional dialogue on military confidence-building.
